15/41	<u>To Receive any Apologies for Absence</u> Apologies were received from Cllr John Furness, Cllr Gareth Dadd and Cllr Bob Baker.	
15/42	<u>To Approve and Sign the Minutes of the Previous Meeting</u> Minutes of 20 October 2015 were agreed as a true record by Cllrs Ashby and Turton and signed by Cllr Kirk, Chairman for this meeting.	
15/43	<u>To Consider Any Matters Arising from the Previous Minutes</u> 15/36 Defibrillator for Boltby Village Hall: Cllr Ashby expressed her thanks for the contribution towards the defibrillator. 15/38 Transparency Code: requirement now met through a link on the Hillside Parish website maintained free of charge by Rik Royall. Thanks were expressed to Mr Royall.	
15/44	<u>To Consider the Financial Position</u> Financial Position: the balance in the current account is £1503.18 (cheques having been raised since the last meeting for clerk's expenses £150, election £100, hire of Felixkirk village hall £80 and contribution of £500 towards a defibrillator). The balance in the savings account is £414.61. The balance now stands at £1917.79.	
15/45	<u>To Consider Planning Applications</u> Felixkirk Church Hall, Felixkirk: Cllrs considered amended plans for this development and agreed that there were no objections on planning grounds; Cllrs are aware that the social committee have raised understandable concerns about the loss of such an amenity to the village. The date for consideration of the amended plans had passed but Hambleton District Council had agreed to await the comments of the Hillside Parish Council before final decisions were made. Dial Stone Farm – erection of 15.2 metre mast with 3 no. antennas and 2 no. dishes together with siting of 3 no. ground based equipment cabinets and associated fencing: again the date for response had passed but North Yorkshire Moors national Park Authority had agreed to extend the date for comments from the Hillside Parish Council. Cllrs considered the plans and had no objections. Annadale, Felixkirk – removal of a fir tree and replanting: Cllr Baker considered the plans on behalf of the Council and had no objections. 15/46	<u>To Receive any Correspondence</u> Correspondence received since the last meeting was noted. Grass Cutting: Cllrs Fairburn and Turton said that they would like the grass verges to be cut in 2016 but noted that despite making this request for 2015, they were not aware that the verges in either village had been cut in 2015. 15/47	<p><u>Any Other Business</u></p> <p>Road closure Upsall to South Kilvington: Cllr Turton was concerned that signs went up to say that the road would be closed for a week and that when the work had finished the signs were not removed; she also asked why the Council wasn't notified. The clerk was asked to raise this matter with Highways.</p> <p>Underground Cables: Cllr Fairburn requested an update on progress with works to install underground cables in Cowesby. Cllr Ashby confirmed that work in this respect was underway in Boltby. The clerk was asked to follow this up.</p> <p>Woundales Lane: Cllr Fairburn noted that Woundales Lane is very close in places to falling into the river. She asked that the clerk notify the clerk for Borrowby Parish Council and Highways.</p>	<p>LF: to action matters raised</p>
