Minutes from the Borrowby Parish Council Meeting held on Thursday November 9th 2017 at 8.00 pm in Borrowby Village Hall

### 1. Apologies

Apologies were received from County Cllr Gareth Dadd and District Cllr B Baker. Present: The Chairman (Cllr F Wachsberger), the Vice Chairman (Cllr D Craig), Cllr D Bell, Cllr E Town, Cllr J Dack, the Clerk and five members of the public.

## 2. Minutes from Previous Meeting

The minutes from the Parish Council Meeting held on Thursday 12<sup>th</sup> October, which were previously circulated and read, were agreed and signed after a small amendment in section 5 to read 'Tom Rennison' instead of 'Tom Anderson'.

## 3. Matters Arising

- 3.1 Parking problem Oaktree Bank The Chairman said cars are still being parked adjacent to the solid white line, causing a hazard to passing drivers. It was said that the school had sent a letter out to parents and the police had spoken to people who have parked there so hopefully the problem will continue to be monitored. Cllr Dack said that the Highway Code states cars should not park adjacent to a solid white line except to unload or drop-off; cars are permitted to overtake and cross the white line.
- 3.2 Cllr Bell has received a quotation of approximately £300 for the pruning of the chestnut tree and trees on the lower Green. Permission to be sought from HDC for the chestnut tree works.

### 4. Update from County and District Councillors if present

### 5. Update from Borrowby Parish Councillors

Cllr Dack – He said that a trip point had disappeared.

Cllr Bell – He said there are now new road signs at the bottom of Park Lane.

<u>Cllr Town</u> pointed out that the gullies near the pub are blocked. A resident said that the drain cleaners had been round the village today.

<u>Cllr Craig</u> – He said the wooden part of the litter bin at the bottom of the village near Bob Lane has rotted. Clerk to report to HDC.

The Chairman – He reported that a few streetlights were off.

### 6. Christmas tree and lighting

The Parish Council discussed where to buy the Christmas tree from. There was a suggestion of purchasing an artificial one but the Parish Council decided to source a real one – to check at Sam Turners and other suppliers for a tree about 18 feet.

# Setting the Precept
